2. Opportunity:

The top Two players from each category as well as the best player from Government schools in both categories (in total 3 boys and 3 girls) will get a life time chance to visit the Olympiad and also to interact with grandmasters and other elite participants through simuls, lectures etc. These players will also be extended 3 nights stay free of cost to witness the Olympiad. In addition, an amount of Rupee 3000/- will be reimbursed for selected player as travel expenses.

3. Selection:

The top Two players from each category will qualify as official entries for the National Championship 2022 and their entry fee will be taken care by Himachal Pradesh State Chess Association.

4. Eligibility:

- Player must be born on or after 01.01.2007.
- Player must be from Himachal Pradesh.
- AICF registration is compulsory for all the players.
- All entries must come through the concerned District Association. However, HPSCA will have the right to accept or reject any entry without assigning any reason.

5. Entries:

No Entry Free will be charged.



Last Date of Entry: 2nd June, 2022.

6. **System of Play:** The Championship will be played under FIDE's Laws of Chess and the Swiss system.
7. **Default Time:** Default time for arriving to the chessboard is 15 minutes.
8. **Time Control:** The rate of play shall be 25 minutes with an increment of 10 seconds per move from move number one.
9. **Tie Break:** Following is the order of tie-break:
 - (a) Buchholz Cut1
 - (b) Buchholz
 - (c) Sonneborn Berger
 - (d) Direct encounter
 - (e) The greater number of wins (forfeit included)
 - (f) The greater number of wins by black
10. **Protest:** if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1000/- to the HPSCA account within 15 Minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.
11. **Appeals Committee:** Before the commencement of the tournament, a five-member appeals committee shall be formed by the HPSCA.
12. **Withdrawal:** If any player is absent for any round without intimation to Chief Arbiter, He/She will be removed for all the remaining rounds without further notice.
13. **Accommodation:** Only player participating in the event will get free accommodation on sharing basis for two days 10th & 11th June.
