2. Selection:

The top two player from each category will qualify as official entries for the National Championship 2022 and their entry fee will be taken care by Himachal Pradesh State Chess Association.

3. Eligibility:

- Player must have Himachal Bonafide Certificate.
- AICF registration is compulsory for all the players.
- All entries must come through the concerned District Association. However, HPSCA will have the right to accept or reject any entry without assigning any reason.

4. Entries:

Entry Fee: Rs.500/- (Rupees Five Hundred Only)/.

Participants need to send their entry to the account number given after confirmation from their respective district.

5. System of Play: The Championship will be played under FIDE's Laws of Chess and the swiss system.

6. **Default Time:** Default time for arriving to the chessboard is 15 minutes.
7. **Time Control:** The rate of play shall be 45 minutes with an increment of 15 seconds per move from move number one.
8. **Tie Break:** Following is the order of tie-break:
 - (a) Buchholz Cut 1
 - (b) Buchholz
 - (c) Sonneborn-Berger
 - (d) Direct encounter
 - (e) The greater number of wins including forfeits
 - (f) Number of wins with Black pieces
9. **Protest:** if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1000/- to the HPSCA account within 15 Minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.
10. **Appeals Committee:** Before the commencement of the tournament, a five-member appeals committee shall be formed by the HPSCA.
