2. Selection:

Two players from each category will qualify as official entries for the National Championship 2023.

3. Eligibility:

- Player must be from Himachal Pradesh.
- State and District Player's registration is compulsory for all the players.
- All entries must come through the concerned District Association. However, HPSCA will have the right to accept or reject any entry without assigning any reason.

4. Entries:

Entry Fee: Rs.750/- (Rupees Seven Hundred Fifty Only)/.

Entry Fee: Rs.600/- (Rupees Six Hundred Only)/ For Sirmaur players.

Participants need to send their entry to the account number given after confirmation from their respective district. Filling the google form is mandatory and the google will be provided by respective District Associations.

Last Date of Entry: 16th August, 2023.

- ## 5. System of Play:
- The Championship will be played under FIDE's Laws of Chess and the Swiss system.

6. **Default Time:** Default time for arriving to the chessboard is 15 minutes.
7. **Time Control:** The rate of play shall be 45 minutes with an increment of 15 seconds per move from move number one.
8. **Tie Break:** Following is the order of tie-break:
 - (a) Buchholz Cut1
 - (b) Buchholz
 - (c) Sonneborn Berger
 - (d) Direct encounter
 - (e) The greater number of wins (forfeit included)
 - (f) The greater number of wins by black
9. **Protest:** if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1000/- to the HPSCA account within 15 Minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.
10. **Appeals Committee:** Before the commencement of the tournament, a five-member appeals committee shall be formed by the HPSCA.
11. **Withdrawal:** If any player is absent for any round without intimation to Chief Arbiter, He/She will be removed for all the remaining rounds without further notice.
